Late fees and collection provisions: *You agree that it is most important that payments be timely made. This helps us keep our administrative costs down which, in turn, allows us to serve you more efficiently.* The term "payments" includes both the proper and timely filing of Purchase Orders if you use a Charter School, and checks or other forms of payment if you will be paying all or any part of the student(s)' fees independently. Unless other arrangements are made, Omni expects payments to be made or Purchase Orders to be signed if the parent or other responsible adult is using a Charter School, *in writing ten (10) days* of signing the Registration Form. If arrangements are made for any type of time payment, the balance due at any time after Registration will bear interest at the legal rate of 10% per annum as set forth in California Civil Code Section 3289(b).

If any payment is more than 10 days late, regardless of the reason therefor, in addition to interest, you agree to pay a late fee of \$50 if the check or other payment is 11-30 days late, plus an additional \$50 late fee if the check or other payment is late by 31 or more days, plus an additional late fee of \$50 for each 30 days thereafter that full payment plus accrued interest thereon has not been paid. If payment remains delinquent by 60 days or more, the child will not be allowed to continue attending the Omni class in

question, and under those circumstances, you agree that you are still liable for payment of fees owed for the entire semester. If we must take action to collect the charges and fees due and unpaid, you agree to pay all costs of collection, including attorney's fees, if Omni must bring action to collect such fees.
